



Woodland Soccer Board & Club Meeting Minutes

Wednesday, August 13, 2014
7:00 p.m., Woodland Community Center

Discussions Points:

1. Team player needs:
 - U14 Rec Boys - need players. Fausto has a few leads.
2. Equipment
 - Game Balls - 3 per team (Tino's team; Guadalajara; United girls Rec; Manchester-Angel; Barcelona). Richard will place the order.
 - Richard gave pinnies to Angel's team.
3. WSC's Financial Situation
 - All Rec Teams have paid for the Fall season
 - Many Comp teams have not paid.
 - We have \$9,000 of operating income
 - WSC sent a deposit check to the city of \$11,390 for Fall fields rental. (We will probably owe an additional \$3,000) This payment is due 2 weeks before each season starts. Field Permits effective August 23.
 - \$22,000 outstanding (13 Comp teams have not paid)
 - 1st installment was due July 1st and 2nd by July 31st.
 - There are still teams that owe lights bill from last winter. (Aug 23 to Oct 13 \$1,300; Oct 14 to Nov 19 \$2,000; Nov 20 to Dec 30 \$1,350; Jan and Feb are more expensive)
4. Chevy donation Presentation:
 - They will donate equipment, t-shirts. \$500 worth of coupons.
 - Every time someone from WSC test drives a vehicle, they will give WSC \$50 up to \$500.
 - Tentatively for Next Wednesday August 20 at Woodland GMC.



5. Conditioning Training:
 - \$500 per month for 2 sessions per week
 - At the diamond - football field WHS
 - Mondays 6 to 7:30 and 7:30 to 9:00pm.
 - All players are welcomed, primarily U12 and up.
 - There are currently 4 teams using it. We will give 2 more weeks, Richard will send an email to get a count of how many teams are using it. Based on that, a decision will be made for following months.
 - Brazilian trainer on hold (\$1,000 per month).
6. Fall Field Allocation:
 - Board gets to pick first.
 - It is up for discussion that for future draws, board coaches can only pick first for one of their teams. A different round for their second team or with the rest of the club.
7. Games:
 - Referees: 3 man system. Play the game under protest with 1 or 2 referees and file a complaint on PDP. No forfeit.
8. Guest Playing
 - Call or send an email to Robert for approval.(liability purposes)
 - No kids or parents making arrangements for guest playing.
 - If reported: 1st offense: \$100; 2nd offense \$150; 3rd offense full suspension of the team.
 - If using a player from the same Club - no problem, there is no protocol.
9. Adult League
 - 19 yrs and up.
10. Try Outs:
 - U8 to U11: January 30th through February 8th. (Season begins 2nd week of March).
 - U12 to U14: February 20th to March 1st.
 - U 15 and up: TBD
11. Uniforms:
 - Nike has not settled yet on what they will do about the uniforms. They recognize there was a flaw on the design and materials.



12. Rec Teams (John Gerald):

- U6/U8 - Goal kicks from the end of penalty box.
- U8: 7 v 7
- U10: 8 v 8
- U12 and up: 11 v 11
- If coach gets a red card, team loses the game.
- U12 - use the 3 man referee system (recommended)
- U14 - 3 man referee system mandatory.

13. Game Cards:

- Use Labels
- Drop the completed Game Card at Patty's house
- Referee fills middle part.

14. Referees:

- Only team captain is allowed to talk to referee. No parents and no coach.
